<u>Subject</u>: Use of our products "MediTainer, MediBowl, MediDuo" (all item codes) as carrier shells for sterile instruments/utensils for the operating room area

Dear customer,

This letter is intended to inform you of a possible problem with the sterilisability of the above products when used as a carrier for sterile surgical kits used in the operating room area

Purpose:

According to the technical documentation, MediTainer, MediBowl, MediDuo are intended for the reception of body excretions and/or as a collection container for smaller waste in the medical field for short-term use.

The following has been found:

During an official review of the products in sterilised surgical kits using a standard method for determining the total germ count, non-sterile carrier shells were detected.

Our products are made of molded fibre material (paper) and therefore cannot be used as a part of a sterile treatment set in the surgical area/operating room area

Possible dangers:

This problem can lead to re-contamination of the surgical utensils and thus could create a possible infection of patients when using a non-sterile surgical kit in the operating room area.

Preventive action:

Please do not use MediTainer, MediBowl, MediDuo" as carrier shells for surgical instruments and surgical utensils or part of another sterile treatment unit for the surgical/operating room area.
