EUROIMMUN has initiated a field corrective action for the product specified above. This notification contains important information for your immediate attention.

**Description of the problem and the determined cause:**

In individual cases the positive control of Anti- $\beta$ 2-glycoprotein 1-ELISA (IgAGM), order no.: EA 1632-9601 P, lot: E211205AL provided in the test kit may yield values outside the acceptable reference range. The respective incubations are invalid, as indicated in the test instruction, and the test results must not be used. Due to the repeat tests which are then required final results may be delayed. All previous, valid results determined with the above-mentioned lot are not affected by this and remain valid.

**Measures to be taken:**

Please ensure that any remaining stocks of the above lot are no longer used in your laboratory.
